# Applying a theoretical framework to solve an educational problem

The cardiothoracic residency program director is unhappy with the skills level of residents in the operating room. The residents are taking too long to operate and are making too many mistakes. She has asked you to propose some solutions, keeping in mind that her department has already invested in simulation training

- Describe an intervention that is guided by a theoretical framework (see Learning Theory Map <u>Learning Theories</u>)
- Describe how you will determine if the intervention is successful. What outcomes will you measure or observe?

### Choose a Learning Theory Option

#### **Situated Learning**

- Learning occurs through participation in everyday practices
  - Observing and talking with others members of a community of practice
  - Gaining legitimacy by completing tasks with progressively more responsibility

#### **Deliberate Practice**

- Attainment of expertise is achieved through deliberate effort, not just experience
  - Occurs in small chunks and is time-limited
  - Followed by feedback (selfreflection or from outside source)
  - Requires motivation
